RELEASE OF LIABILITY AND ACKNOWLEDGMENT OF RISK

1. I have read and understand the description of the events and the Official Rules of the events. I will obey all rules and understand that any violation may result in immediate disqualification without refund of my entry fee. I also understand that tournament officials may reject my application for any reason and in that event will refund my entry fee.
2. I understand and acknowledge that competitive fishing is a dangerous sport, the risks of which include, though not exclusively, drowning, collisions in the water, and injuries from hooks and other fishing paraphernalia. I voluntarily assume responsibility for these risks, identified and not identified, and all risk of injury or death or damage to myself, or my property or to others, including spectators and their property, arising from my participation in the events.
3. I hereby release, discharge, and agree to hold harmless and indemnify Bedford Sales & Outdoors LLC., it's officers, directors, agents and employees, the host, sponsors and tournament officials, and its partners, agents or employees, and all other persons or entities associated with Bedford Sales & Outdoors LLC from any and all liability, claims, demands, actions or rights of action which are related to, arise out of, or are in any way connected with my participation in these events, including specifically but not limited to the negligent acts or omissions of Bedford Sales & Outdoors LLC its officers, directors, agents and employees, the host, sponsors and tournament officials, and its partners, agents or employees and all other persons or entities associated with the events, for any and all injury, death, illness or disease, and other damage or loss to property suffered by myself or others. 6. I have sufficient health, accident, and liability insurance to cover any bodily injury or property damage incurred by myself or others as a result of my participation in these events. If I have no such insurance, I represent that I am capable of paying for any and all such expenses or liability.
7. I have no past or present medical or psychological condition that might affect my participation in the events in such a way as to cause harm to myself or others.
8. I give Bedford Sales & Outdoors, LLC permission to use my name and photograph for promotional purposes.
